WHAT COULD GO WRONG? #1 - GIFT PROPERTY FOR A COMMUNITY SERVICE CENTER

- Things that didn't happen with the gift
 - No Local board approval in the minutes to receive the property
 - No Association board approval in the minutes
 - No recordation of the asset in the Plant Fund
 - No Property/Liability insurance
 - No Hazardous waste sight investigation, Phase 1 and Phase 2

ARCO

- Atlantic Richfield Company
- Superfund act CERCLA Comprehensive Environmental Response, Compensation, and Liability Act of 1980
- USTs Underground Storage Tanks filled with concrete slurry fluorocarbons detected!
- Lessons learned What can we do better?

WHAT COULD GO WRONG? #2 - GIFT PROPERTY FOR A NEW CHURCH

- A new church Williamsburg VA
 - A retired GC treasury person fundraises for the church
 - The church has a small mortgage when completed
- We receive a notice from an attorney
 - There was a lien on the property property had been part of a larger parcel with mortgage
 - Property received by a quit claim deed!
 - No title search was performed
 - No hazardous waste site investigation
 - No Association Board approval
 - We were able to settle for \$30,000
